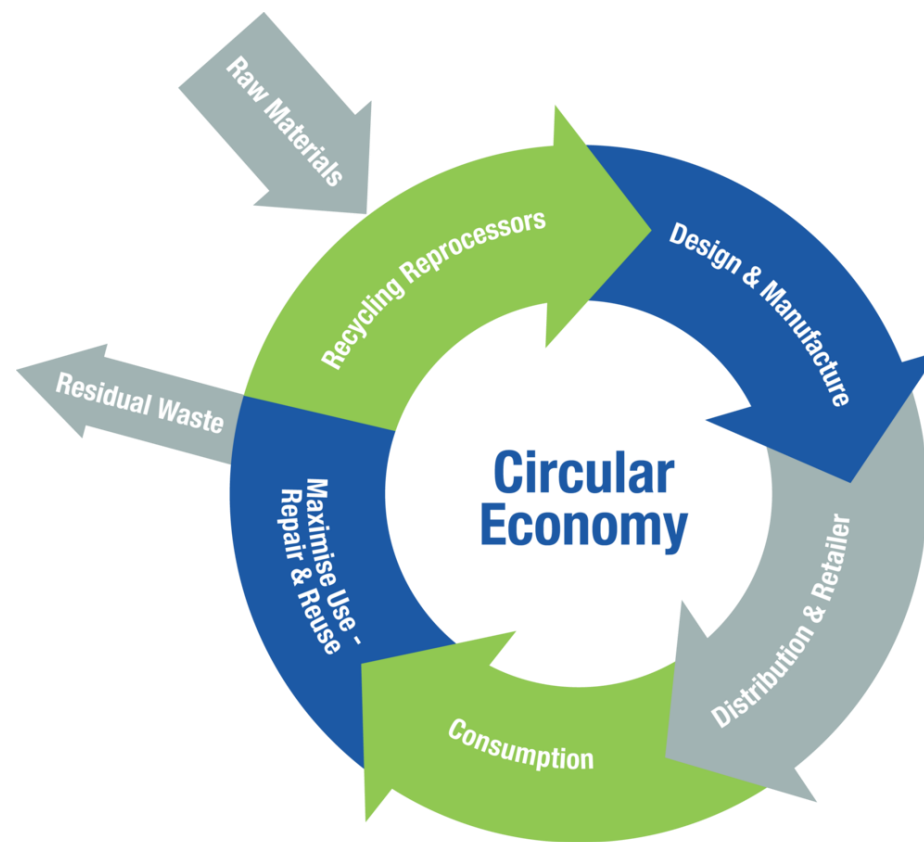

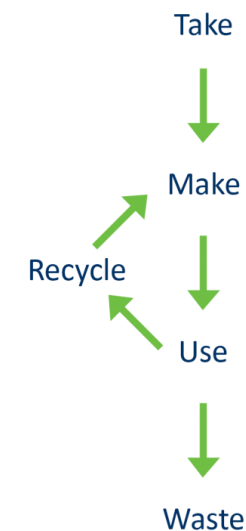
- 🍃 Prevention

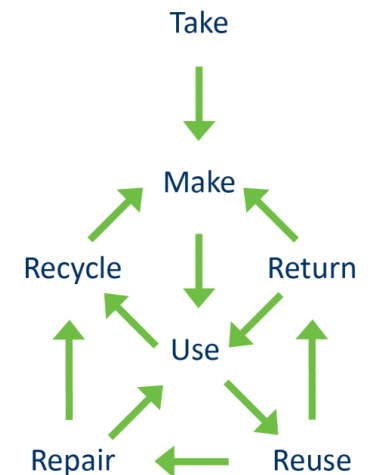

Waste collection and transport hazardous and non-hazardous

La Lucente Ecologia employs specialised personnel and specially equipped vehicles to carry out waste collection.

Brokering and/or trade in waste

La Lucente Ecologia acts as a link between the waste producer/holder on the one hand and the final recipient on the other. It strives to ensure the producer the best environmental and economic waste management.



Gathering, handling waste and temporary storage management

La Lucente Ecologia also performs an integral service directly at the producers' premises: before disposal, it groups the waste, handles it, labels it and packages it by homogeneous categories.

Remediation of assets containing asbestos

The asbestos abatement and reclamation service provided by **La Lucente Ecologia** is comprehensive: environmental monitoring and analysis to detect asbestos fibres, management of bureaucracy related to the abatement process, management of the final stages of the asbestos abatement process.

LA LUCENTE ECOLOGIA - Case study



Within a major production facility of a well-known national group, La Lucente Ecologia performs **waste handling, grouping and temporary storage management services for waste** (hazardous and non-hazardous).

La Lucente Ecologia's employees, appropriately trained and qualified, collect the waste produced within the plant in a differentiated manner, handling it from proximity bins and placing it in 25 cubic metre bins.

These skips are picked up by a lorry equipped with roll-off equipment and delivered to the temporary waste storage facility, where the waste is grouped, also with the help of a hydraulic loader, labelled and stored separately.
